(a): No Sir, Public and private jute producing companies/ Jute mills have not been able to meet the requirement of new jute bags by the States for procurement of foodgrains during the years 2018-19, 2019-20, 2020-21, 2021-22 (current financial year) due to their limited production capacity of jute bags.

(b)to(d): Based on the requirement of packaging material by the State Procuring Agencies (SPAs) including Chhattisgarh & Food Corporation of India(FCI), commitment by jute industry & foodgrain procurement estimates, GoI prepares month-wise supply plan for all the SPAs & FCI. Accordingly, SPAs & FCI places indents with Office of Jute Commissioner which in turn issues Production Control & Supply Order under the Jute & Jute Textiles & Control Order, 2016 to different jute mills for supply of jute bags as per relevant BIS standard. In this regard, no contracts are signed.

The details of demand and supply of bardana (jute) bags for Kharif crops to State of Chhattisgarh are as under:

To avoid short supply of jute bags for packaging of foodgrains, following steps are taken:

a)Permission for use of good quality used jute bags, are granted to SPAs/FCI. States/FCI are also permitted to arrange new jute bags from sources other than the Office of Jute Commissioner, Kolkata.

b)Dilution in packaging norms for use of High-density polyethylene or polypropylene (HDPE/PP) bags as per provisions of Jute Packaging Materials(JPM) Act, 1987 is obtained from Ministry of Textiles.
