- (a):The state-wise details of the production of sugarcane during the previous Sugar Season 2020-21 (Oct-Sep) is attached at Annexure.
- (b):No such proposal is under consideration of the Government of India. However, Govt of Bihar is providing financial assistance to the farmers under the State Plan through Mukhyamantri Ganna Vikas Programme. Under this Programme State Government is providing the subsidy to the farmers during 2021-22 in following components-

- 1)Incentive for Breeder Seed Production
- 2)Incentive for Foundation Seed Production
- 3)Incentive for Certified Seed Production
- 4) Subsidy on distribution of Certified Seed
- 5) Subsidy on distribution of bio-fertilizer & Bio-Compost.
- 6) Training and seminar etc.
- (c) & (d):Yes, at present Central govt. fixes Fair and Remunerative Price (FRP). Accordingly, FRP for 2021-22 sugar season has been fixed at Rs. 290 per quintal linked to a basic recovery of 10% subject to a premium of Rs. 2.90 per quintal for each 0.1% increase of recovery over and above 10% and reduction in FRP at the same rate for each 0.1% decrease in the recovery rate till 9.5%.

In Uttar Pradesh, Haryana and Punjab, State Administered Price (SAP) is declared each year by the respective State Government.
